- Certificate of Good Standing/Incumbency if company is over 1 year
- Register of Directors and Members
- · Organogram of the company
- · Business Plan

## **Personal Documents Required**

- Certified Proof of Identification, the ID document can take the following form, Passport, ID Card, Driving License
- Certified Proof of Address This could be a Utility Bill, Bank Statement, Credit Card Statement, Etc.
- · Reference letter

If any of the above documents are not in English, a translated copy must be obtained.

## **Documents required for any Corporate Officer**

- · Certificate of Incorporation
- Memorandum and Articles Or similar document containing the companies rules
- · Register of Director/Shareholder/Members
- · Share Certificate

All documents should be in English, if not the documents should be translated into English and certified the same.

### **Currencies Available**

# Visit Required

A visit to Saint Lucia is not required to open this Business Bank Account. The Account can be opened remotely via email and telephone communication.

# **Initial Deposit**

At least 1,000EUR or currently equivalent should be deposited into the account once it has been opened. This amount should also remain in the account at all times.
